May Talk: 'Hidden' History of the Ancient Burying Ground

atherine Hermes,
Interim Chair of the
Department of History
at Central Connecticut
State University, will be the
speaker at the 2021 Annual Court
of the Society of the Descendants
of the Founders of Hartford. She
will discuss her work uncovering
the early African, African
American, and Native American
burials in Hartford's Ancient
Burying Ground – a subject
unknown to many.

Because of the COVID-19 pandemic, her talk will be a virtual one, held on Zoom. For information about attending, see the accompanying box.

The Court will be held on Tuesday, May 11 at 7:30 p.m.

Dr. Hermes received her A.B. in history, cum laude, from the University of California-Irvine, in 1985; an M.A. (1987) and M.Phil. (1988) in history at Yale; a J.D. from Duke School of Law in 1992: and her Ph.D. in Colonial American history from Yale in 1995. She has taught at Central Connecticut State University in the History Department since 1997 and was Department Chair from 2012-2018. She teaches courses on Anglo-American legal history and Native Americans of the Eastern Woodlands, as well as other courses in Early America.

To investigate burials of non-Europeans in the Ancient Burying Ground, a part of the history that has largely been hidden, Dr.

Hermes developed a type of software that allowed her to look into the early history of the Lord and Woodbridge families with their slaves and servants.

She is the co-author with Alexandra Maravel of several articles and book chapters on Native American history in New England and the author of book chapters on Native legal history. She is the director of the "Uncovering Their History" project.

Although much has been written about the history of the English who founded Hartford, relatively little has been told of the lives who accompanied these families. Dr. Hermes' presentation should be a compelling one.

The Ancient Burying Ground is Hartford's oldest historic site and the only one remaining from the 17th century. During that period, anyone who died in town could be buried there. Until recently, little was known about the identity of those of African and Native American heritage buried there.

Society's Seal Is Re-Drawn

From the first, the Society of the Descendants of the Founders of Hartford has prescribed a seal for the corporate body:

"The seal of the Society shall be: within a beaded annulet, bearing the words 'Society of the Descendants of the Founders of Hartford' on a shield argent, a cross of St. George gules for England; in the first quarter, a hart trippant proper for Hartford; and in

each of the other three quarters, a grape vine leaved and fructed proper for Connecticut." (From Article VI of our By-Laws)

This description -- not quite a heraldic blazon, nor yet an ordinary prescription for a seal -- has received more than one interpretation, with the 'annulet' misprinted most recently as an 'amulet'! (Henry McNulty, who was Founders Governor from 1995 to 2005, also tells of one apologetic artist who regretted that he couldn't get quite right 'the moose' in the first quarter! The artist didn't realize it was a hart.)

This new redrawing has now been cut in a brass embossing matrix, with which engraved diplomas of membership or other documents of great importance would be sealed. It restores the annulet, adds the year in which our Society was established -- and, we may hope, has a hart in the first quarter instead of a moose.

A New Look for The Certificate

Sometime after the establishment of our Society in the Spring of 1931, we began to issue small printed certificates to newly admitted men and women. Most recently, the certificate was printed in a Roman typeface, showed the then-current rendition of the seal of the Society, and provided spaces for entry of the new member's name, qualifying ancestor, date of admission, and Society serial number. Space was provided, too, for the signatures of the Governor and Secretary.

The new certificate is printed in "Ayres", a typeface more appropriate to the seventeenthcentury founding of Hartford. Named after John Ayres, a famous writing master (that is, calligrapher and instructor in handwriting) working in London a generation after the event we celebrate, this typeface is a transitional form between the late chancery hand in which the better-educated amongst our ancestors still wrote in the 1630s and the Spencerian script which our older members may still remember from tedious grammarschool hours with dip pen and inkwell.

In drawing the typeface, modern German type designer Gert Wiescher aimed to present a clear and legible vertical script which nonetheless remains faithful to the more ceremonial English writing of four centuries ago.

In keeping with the mid-17th-century spirit, the new certificate, while providing all the information given on earlier certificates, has been reworded to approximate the formal presentations of that period. The appearance, too, is appropriate to a legal document of

the Puritan age, while retaining space for official signatures and the newly redrawn seal of the Society.

Although this new certificate, in black offset printing on a stiff white card stock, is issued to members only at the time of their admission to the Society, the Council is investigating the possibility of obtaining larger, engraved diplomas of membership which all members, new or venerable, may obtain in similar format.
